REGISTRATION AGREEMENT, INDEMNITY & CONSENT

(Applicable to all Johannesburg Basketball Academy NPC ("JBA") programmes and activities. Where the Participant is under the age of 18 years, this Agreement must be accepted by the Parent or Legal Guardian.)

By registering for or participating in any programme, training session, league, tournament, clinic, camp, outreach programme or other activity organised or facilitated by JBA ("Activities"), I acknowledge and agree that:

1. **Assumption of Risk:** Participation in basketball and related activities involves inherent risks, including injury, illness, permanent disability, death, damage to or loss of personal property, and other unforeseen risks. I voluntarily accept these risks on behalf of myself or the Participant.
2. **Indemnity:** To the fullest extent permitted by South African law, I release, waive, indemnify and hold harmless JBA, its directors, members, employees, coaches, volunteers, officials, agents, sponsors, partner schools, venue owners and affiliated organisations from any claim, liability, loss, damage, cost or expense (including reasonable legal costs) arising directly or indirectly from participation in any JBA Activity, except where liability arises from gross negligence, fraud or wilful misconduct.
3. **Medical Consent:** I confirm that the Participant is medically fit to participate and that any relevant medical conditions have been disclosed. In the event of an emergency, I authorise JBA to obtain emergency medical treatment where reasonably necessary. Every reasonable effort will be made to contact the Parent, Legal Guardian or emergency contact. All medical and related costs remain my responsibility.
4. **Participant Conduct and Safety:** I agree that the Participant will comply with JBA's rules, policies and instructions and will conduct themselves with respect and good sportsmanship. JBA may suspend or remove any Participant whose behaviour is unsafe, disruptive or inconsistent with the Academy's values or where continued participation may place themselves or others at risk.
5. **Child Safeguarding:** JBA is committed to providing a safe environment for all Participants. I acknowledge that JBA may investigate and, where required by law, report any safeguarding concerns, including allegations of abuse, neglect, bullying or other inappropriate conduct.
6. **Personal Property and Insurance:** Personal belongings remain entirely at the Participant's own risk. JBA and Affiliates accepts no responsibility for the loss, theft or damage of personal property. Unless expressly stated otherwise in writing, JBA does not provide personal accident, medical aid or property insurance.
7. **Media Consent:** I consent to JBA photographing, filming or recording the Participant during Activities and using such material for educational, promotional, marketing, fundraising and communication purposes, including on JBA's website, publications and official social media platforms, without compensation.
8. **Protection of Personal Information (POPIA):** I consent to JBA collecting, storing and processing the Participant's personal information in accordance with the Protection of Personal Information Act, 2013 (POPIA), solely for registration, administration, communication, safeguarding, competition registration, legal compliance and the operation of JBA. Personal information will only be shared where required by law or reasonably necessary for these purposes.
9. **Acceptance:** By selecting "I have read and agree to the Johannesburg Basketball Academy Registration Agreement, Indemnity & Consent", I confirm that I have read, understood and voluntarily accept this Agreement. Where the Participant is under the age of 18 years, I confirm that I am the Parent or Legal Guardian and have the legal authority to accept this Agreement on the Participant's behalf. My electronic acceptance shall constitute a legally binding agreement and this Agreement shall be governed by the laws of the Republic of South Africa.
